STATE REQUIREMENTS

According to the state of Pennsylvanina each student must complete 1250 hours which include theory and practical training over the course of 9 or 18 months, depending on full time or part time. The State Board of Pennsylvanina states that Cosmetologist will be given 555 hours of credit for subjects previously covered.
